The Sandakpur Rural Municipality, Office of Rural Municipal Executive Mabumod,Deurali,Ilam,1 no Province , Nepal invites sealed bids from eligible bidders for ***Sandakpur Ward no 1 Building Construction Work/ Adarniya Secondary School Building Construction/ Balkalyan Basic Elementry School Building Construction Work/ Bhanu Basic Elementry School Building Construction Work.*** .
2. Eligible bidders may obtain further information and inspect the Bidding Documents for Procurement of Work at mentioned above office, Ph No:9841899063, or may visit PPMO website www.bolpatra.gov.np/egp.
3. ***Contract Identification No: SRM/Ilam/NCB/Work/03/076-77; SRM/Ilam/NCB/Work/04/076-77 SRM/Ilam/NCB/Work/05/076-77 ; SRM/Ilam/NCB/Work/06/076-77 ;*** Bidding is open to all eligible Nepalese Bidders.
4. The Bidding document, in English language, will be made available to eligible bidder on the submission of a written application along with the copy of company/firm registration certificate and tax clearance certificate of FY 2075/076 from Office as mentioned in Para 1 upon payment of amount of a non-refundable fee of **NRs 3000.00 (NRs Three Thousand only)** on or before the office hour until **20th Feb,2020**. If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional cost of **NRs. 1000.00 (NRs One Thousand only)**. However, the Employer will not be responsible for delay or non-delivery of the documents so sent. The method of payment will be in cash. The document can be purchased by the bidder or his/her authorized representative. For the purpose of Bidders who choose to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site: www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the **Sandakpur Rural Municipality's** Rajaswa (revenue) account no: **Revenue Account No: 19000101100100000001, Prabhu Bank Limited, Sandakpur Branch, Ilam** and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.
5. Sealed Bids must be submitted to the above office of ***Sandakpur Rural Municipality, Mabumod, Deurali, Ilam*** on or before **21st Feb,2020 12:00 hrs**.
6. Bids shall be opened in the presence of Bidders' representatives **21st Feb,2020 13:00 hrs** at the office of ***Sandakpur Rural Municipality, Mabumod, Deurali, Ilam*** . Bids must be valid for a period of 120 days.
7. If the bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in the form of Bank voucher drawn in the name of **account No: 19000201100100000004, at Prabhu Bank Limited, Sandakpur branch, Ilam** or Bank guarantee drawn in favor of this office, having a validity period of 90 days from the last date of submission of the bid. Bid security must remain valid for 30 days after the bid validity period.
8. Pre-Bid meeting shall be organized on **9th Feb,2020 13:00 Hrs**, Sandakpur Rural Municipality, Mabumod, Deurali, Ilam.
9. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
10. Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
11. Any intimidation, collusion and cartelling during bidding process shall be punishable by law.

12. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
13. Any additional matters not covered by Invitation Notice and mandatory information shall be in accordance with prevailing **Public Procurement Act 2063 (with latest amendment 2073) and Public Procurement Regulation 2064 (with latest amendment 2073)** of the Government of Nepal .
